## **Event Registration Instructions and Troubleshooting**

In 2025 NGA upgraded its event registration and membership database systems. The new system requires those registering for events to have an account in our system. This guidance document will walk you through creating your account, common issues that may occur, and general registration for an event.

## **Common Issues and Trouble Shooting**

#### Receiving a Message That You Are Not Eligible to Register for This Meeting



This is the most common issue that may occur in the registration process if the event requires membership to NGA. It can occur for one of two reasons:
